President's Message

The 2022 Legislative Session has finally come to an end.

The Senate was able to finally pass the bottle bill and make a number of changes. The final bottle bill was not what the League had advocated for and does not benefit lowans.

However, the Governor's plan to issue scholarships to individual students to attend private schools did not pass this year. The League and most lowans did not support this proposal because of the dramatic harm this would do to public education in Iowa.

LWVUS Convention

The League of Women Voters of the U.S. Convention will be held on June 23 - 26, 2022, in Denver, Colorado.

Every League has voting delegates according to the number of members in the League:

1 - 49 members = 1 delegate 50 - 99 members = 2 delegates 100 - 149 members = 3 delegates

One additional delegate shall be authorized for each additional 50 voting members.

Delegates and attendees will have the option to attend either in person or virtually.

The cost for registration is \$475 for in person and \$300 for virtual.

We are also very concerned about the lack of transparency and accountability in the state government today. This will need to be a major focus for the LWV of Iowa going forward, and we will need to find ways to address this lack of transparency and accountability. Our work to advocate for issues and defend democracy is an ongoing task.

Soon after the draft opinion from the Supreme Court was leaked, the LWV of Iowa was asked to join several organizations to plan a rally in Des Moines. We held it on the west steps of the State Capitol on Saturday, May 7, at 3:00 p.m. It was well attended and the speakers were excellent. We were there defending women's rights for reproductive health care.

The LWVUS also issued a strong statement:

"Reproductive care is essential health care and a fundamental right that the Supreme Court is preparing to undermine. All people deserve access to quality health care, including abortion, and the privacy to make reproductive choices."

This is an issue that we will continue to advocate for.

We will gather for our first in-person event since February 2020 at Council in Cedar Falls on June 4, 2022. This will be a great opportunity to elect new officers and to vote for the proposed budget.

We will learn more about what is happening in local leagues and be introduced to the new local League, LWV of North Iowa. We are fortunate to have Chris Larimer, UNI Political Science Professor, as our guest speaker and to learn about the Iowans for Responsible Gun Laws. We are also hoping that Dr. Deborah Turner can join us if her schedule allows.

I am looking forward to seeing many League members at Council!

LWVIA Council is held in the interim year between State Conventions. The Council shall be composed of two delegates from each local League, Members-at-Large (MAL) unit, and the State Board members.

This important meeting includes the election of Vice President, Treasurer, and two Board of Directors members; gives guidance to the Board of Directors on program and methods of work; adopts a budget for the ensuing year; transacts other business presented to the Board; and offers training to attendees.

We will also have a featured speaker, Professor Christopher Larimer. He is Professor of Political Science at the University of Northern Iowa, where he also serves as the Program Coordinator for the Master of Public Policy program. Larimer's research focuses on voter turnout, public policy, and Iowa politics. Our priorities for engagement can be found in the areas represented by the speakers. The Farm Bill (a government program to encourage good use of the land along the Mississippi by farmers) and Mississippi River Restoration and Resilience Initiative (MRRRI) remain priorities. PFAS (per- and polyfluoroalkyl life time chemical substances) has been added as a priority due to these contaminates found in our rivers in Iowa and all over the nation.

UMRR-ILO will be educating members and acting on behalf of these initiatives. We need to learn about these areas, educate others, and work to keep our rivers in the four-state area and everywhere clean and useable.

League-impact Legislation for Children/Adolescents

Reflecting the League's continual concern for children and reflective of societal issues across time By Linda Meloy, LWVIA State Board

Child health - Department of Health services for the deaf (1975).

Required immunizations of children for German measles, mumps, diphtheria, whooping cough, tetanus, and polio before entering school, with exceptions granted only for religious reasons (1997).

Insurers required to allow a 48-hour maternity stay in the hospital for a regular delivery and a 96-hour maternity stay for a C-section (1996), called the "drive-by delivery bill" (1996).

Hawk-I Children's Health Care (CHIP) covering children up to age 19 from certain poverty level households (routine checkups, immunizations, doctor visits, prescriptions, dental and vision care, lab and X-ray services, and outpatient hospital care) (1998).

Single-pack cigarettes to be placed behind store counters so that children and young adults could not have easy access, as well as the prohibition of advertising of cigarettes near playgrounds and schools (1998).

Prohibition of giving away cigarettes and tobacco products as free samples and banning of promotional give-aways in concert with the sale of cigarettes and tobacco products (1999).

Establishment of ABLE (Achieving a Better Life Experience) Accounts (like college saving plans) that allow children and adolescents with disabilities to save money for future living or education services, without impacting eligibility for Medicaid or Social Security (2016).

Early Funding of State League in Iowa

Since next fiscal year's LWVIA Budget is on the June 2022 Council Agenda (as it is yearly at council or convention), here's a bit of history on the early funding of the State League in Iowa...from League Finances a la the 1919-44 History of the League in Iowa...

"The lowa League of Women Voters has made no outstanding record which would serve as a model in financing its own activities. As far as the League Minutes from 1919-44 show, it accepted and followed the inherited custom of its forbearers in requiring only small dues from its members and **depending largely on munificent contributions of men and women who believed in the value of education** for women **for effective citizenship**, and were willing to assist in maintaining it as a greatly needed aid to an effective democracy. Had the League been created as a Lodge, or a Benevolent or Relief Organization, that system of finance might have been tenable, but, since it [was and] is none of those, its budget began to dwindle when large fortunes became more rare and the first flush of popularity for the citizenship training for women passed its peak."

Are we aiming for financial support from the "munificent contributors" in our state?

68,234 homeowners in Iowa have a net worth of 1 million dollars or more (2.27% of our population). The top 20% of households (600,000) earn \$193,000 or more each year. So there are individuals out there who could be "munificent contributors" to the League (individuals who could give larger and more generous amounts of money than is usual).

Are we documenting our many and varied actions Defending Democracy that could lead them to the donation button on our webpage or to a local League member in their community? Are we heralding particular individuals in our state who make significant contributions to society that are consistent with League values and who could be future contributors to support our work?
