Criminal and Juvenile Justice Committee (CJJC) Update

We have been working on assembling information about the cost of being incarcerated or even just accused of a crime.

Some of the information we are developing:

- If a person is arrested, but cannot post bail, he/she is likely to receive a sizable bill for their own incarceration even if the person is found to have done nothing wrong!
- The person who cannot post bail is much more likely to be sent to prison on disposition of their case. There is a "poverty penalty."
- The debt currently discussed as owed to the state can cost the state more in collection efforts than the revenue it will ever receive.

Mississippi River Network (MRN) Update

The Annual Meeting of the Mississippi River Network (MRN) was held in New Orleans during the week of October 4 - 11. Next year it will be held in Orlando. I do hope someone will join me in this educational, stimulating, and social event. The people who care about and work for the Mississippi River have many different roles and talents to support the River. In the northern part of the River we are more focused on our carbon pipelines, the restoration of the Great Lakes, containments for animal production organizations.

We are all concerned about flooding. I had no idea how flooding has impacted the rainforest areas of Florida until several of us at the meeting visited a long-time resident of Florida who had documented the desecration of the rain forests through the years. The deforestation of the rainforests using the cedar trees to make furniture or mulch has contributed excessively to the damage from Hurricanes Katrina and lan.

We are all concerned about water usage. Twenty million people get their drinking water from the Mississippi River. As was documented in Jackson, MS, following Hurricane Ian, water had to be brought in for weeks because of the flooding. Barges and cruises were stuck on the River because the water level was at its lowest in thirty years.

Our Mississippi River is full of life, but cannot remain that way unless we care for it and respect its needs. Some of you will remember Jarod McGovern. He was our superior guide when we visited the National Mississippi River Museum in Dubuque for the River Days of Action 2022. He was at the MRN Annual Meeting as well as 55 friends and friends-to-be. We are already in the thought process of planning our River Days of Action for June 8 - 18, 2023. If you are interested in helping, let me know, because we will begin meeting on December 3, 2022. Any and all MRN friends are invited. If you want to offer ideas or are just curious, you will be welcome at planning meetings.

I have a detailed outline of the MRN Annual Meeting by Kelly McGinnis, Mississippi River Network CEO. If you want to see the 19-page copy, let me know. All League members can access the links on our MRN website (<u>1mississippi.org</u>), because your local League of Women Voters joins the Upper Mississippi River Region Inter-League Organization (UMRR-ILO), and the UMRR-ILO (website: <u>lwvumrr.org</u>) is a member of the Mississippi Regional Network (MRN). Your local League only needs to pay \$25 to join. Anyone can join or be an active part of either network by going online to <u>1mississippi.org</u> or <u>lwvumrr.org</u> to donate, see activities, or view previous events.

It may be too cold to enjoy the Mississippi River right now, but its impact on all of us is constant. Our UMRR-ILO Board meetings are held in even-numbered months on the first Monday of the month. Our advocacy committee has been working hard meeting monthly to increase our political knowledge and impact for the four-state area of Iowa, Minnesota, Wisconsin, and Michigan. On October 3, 2022, we had a very interesting presentation from Ms. Jess Mazour of the Sierra Club, Iowa Chapter, concerning the carbon pipelines.
