

January 13, 2025

Session Begins: Speech Week (Governor, Chief Justice, Guard)




March 7, 2025

First Funnel: Bills must be voted out of originating committee*



May 2, 2025

"Last Day" of Session: 110th day (no more pay)



February 14, 2025

Individual Bill Deadline: last day for individually sponsored bill requests



Second Funnel: Bills must be out of second chamber's committee*



Governor has 30 days from session's end to sign or veto bills



TRANSPARENCY & CITIZENSHIP

Demand government accountability and transparency by requiring all amendments and bills discussed in committee to be available to the public prior to a vote. Demand timely processing of Freedom of Information Act (FOIA) requests. Encourage direct citizen participation by continuing virtual committee and subcommittee meetings. Reinstate gender balance requirements for appointed boards and commissions.



Provide oversight and track public funds being used for non-public schools. Require any non-public school receiving public funds to meet the same standards as public schools. Fully fund public schools and reinstate all AEA functions. Continue to expand access to affordable childcare and free four-year-old preschool.

FE REPRODUCTIVE RIGHTS

Guarantee access to the full range of women's reproductive health services. Repeal the six-week abortion ban. Make contraception available without prescription and promote programs that help prevent unplanned pregnancies. Ensure Medicaid services are comprehensive and accessible. Set policies that attract maternal health professionals and address the state's OB/GYN deserts.

▲ ENVIRONMENT

Recognize the need for and fund water quality initiatives. Fully fund REAP. Develop state climate change strategies.

GUN SAFETY

Enact comprehensive common sense gun safety legislation. Ban assault rifles and military-grade weapons. Enact background checks on all gun sales, close gun show loopholes, require gun safety locks, repeal "stand your ground" law, and oppose legislation that allows the carrying of guns in schools.


Human Trafficking
